Tips to Lower Your Water Bill

Using water efficiently not only helps extend our water supplies for tomorrow but can help lower your water bill today.

- Turn off your sprinklers and use water sparingly this winter to reduce monthly sewer charges year round.
- Use this time to make landscape changes by removing some unused turf areas and replacing them with mulched landscape beds with native perennials and grasses that add beauty and variety while using much less water and fertilizer.
- Go to <u>www.txsmartscape.com</u> for suggested plants for our area, care and maintenance tips, and other resources to help save water outdoors.
- Fix leaking faucets and toilets that can account for up to 10% of total indoor water use.
- Replace your showerhead with a high-efficiency showerhead that uses 2.0 gallons per minute or less. Remember, anytime you use less hot water you are saving money on water and energy.

Important Information:

- A 5% past due fee is added to water and sewer bills when the bill is not paid by the due date. The 5% is calculated on the current month's water and sewer charges.
- All commercial and apartment irrigation systems must be equipped with rain and freeze sensors. All residential irrigation sprinkler systems installed on or after January 1, 2007 must be equipped with rain and freeze sensors. It is a good idea for all homes with irrigation systems to install rain and freeze sensors.

Effective January 1, 2014 UTILITIES RATES UPDATE

This years' rate increases for water and wastewater services are set to go into effect on January 1, 2014. The typical residential customer's monthly water and wastewater bill will increase by \$4.90 per month.

Why is a rate increase necessary?

The primary drivers for this years' water and wastewater increases are from raw water purchase and wastewater treatment costs. Tarrant Regional Water District, raw water supplier for Arlington, Fort Worth and Mansfield, is constructing a major water supply project to bring additional water into Tarrant County for future needs. The wastewater increase is associated with the Trinity River Authority's facilities and pipeline rehabilitation projects. These are impacting the entire region, and will result in additional rate increases over the next several years. Arlington Water Utilities will continue to work diligently to reduce controllable costs and gain efficiencies in an effort to mitigate customer rate impacts.



ACCEPTED:

- Controlled, non-controlled, and over the counter medications
- All solid dosage pharmaceutical product and liquids in consumer containers; liquid products, such as cough syrup (please keep sealed in original container.)

NOT ACCEPTED:

- Intravenous solutions, injectables, and syringes
- Illicit substances such as marijuana or methamphetamine

TIPS:

- Participants may dispose of medication in its original container or by removing the medication from its container and disposing of it directly into the disposal box.
- All participants must retain possession of their own medication during the surrender process.

Properly Dispose of Prescription Drugs

- Whenever possible, take your unused pharmaceuticals to a pharmaceutical collection event. **Note:** If you choose to store your waste while you wait for a pharmaceutical collection event to occur, please minimize the risk of accidental poisoning, overdose or diversion (illegal use by someone other than the intended person) by storing medications out of reach of children or in a locked cabinet.
- Dispose of your unused pharmaceuticals in the trash. Especially when there is a risk of accidental poisoning, overdose or diversion, it is better to dispose of household pharmaceuticals than to hang onto them. When placing unused pharmaceuticals in the trash, be sure to do the following:
 - Remove or mark over all labels that identify the materials as pharmaceuticals or that could provide personal information about you, including prescription information that someone could try to refill.
 - Render them unattractive to children and thieves by dissolving them in a small amount of water or alcohol, or by grinding them up and mixing them with coffee grounds or kitty litter; and put them in a second container or small plastic bag and hide them in your trash.
 - Never burn pharmaceuticals or personal care products in a burn barrel. Uncontrolled burning can create dioxins and other air pollutants.
 - Never flush pharmaceuticals down the toilet or pour down the drain.





Help prevent unpleasant accidents by properly disposing of broken glass, sharps and needles

Arlington residents - before tossing into a garbage bag for curbside collection, please:

- Place sharps and needles in a empty laundry detergent jug or bottle. When the container is full, secure the lid and seal it with tape.
- Wrap broken mirrors and glass in newspaper and tape OR place in a cardboard box clearly marked "broken mirror" or "broken glass."
- Place broken bottles or jars in a cardboard box clearly marked "broken glass."

Stage 1 Drought Restrictions Update

Tarrant Regional Water District's water supply is below 75% capacity. Mandatory watering restrictions are necessary at this time to help extend supplies and potentially avoid entering Stage 2 water restrictions at 60% capacity. Continue to water only when needed and use the two day schedule for sprinkler systems. Remember: no outdoor watering between 10 a.m.-6 p.m. year round and hand watering, soaker hoses and drip irrigation are allowed any day and any time.



Are you prepared?

Develop a family emergency plan:

- Create an emergency safety kit with drinking water, blanket, first aid, a radio and a flashlight.

- Post emergency telephone numbers and teach your children how to dial 911.

Safeguard important documents in a waterproof container or a safe deposit box:

- Copy of all insurance policies, personal identification papers and other important documents.
- Household inventory- written list and pictures of all major household items and valuables.

Prepare your home:

- Keep gutters and downspouts clear of debris.
- Move valuables and important documents to a safe place.
- Raise electrical components in and around your house above projected flood elevations.
- Anchor light objects or fuel cans or tanks.

The City of Arlington participates in the National Flood Insurance Program which makes federally-backed flood insurance available to residents of the City whether the property is in the floodplain or not. We also participate in the Community Rating System which provides flood insurance discounts to residents based on the City's implementation of floodplain management practices.

There are two types of flood insurance coverage: building and contents. This allows both homeowners and renters to have coverage from losses caused by flooding.

Homes and commercial buildings located in flood hazard areas are required to have flood insurance if they have a federally regulated mortgage.

Twenty-five percent of all flood claims are from outside of the floodplain, so it is important for homeowners to evaluate their risk to determine if a flood insurance policy is necessary.


