- II. The Pledge was led by Commissioner Moise.
- III. Commissioner Smith moved to approve the minutes of the February 15, 2017, P&Z Regular Session Meeting. Seconded by Commissioner McCurdy, the minutes were approved by a vote 8-0-0.

IV. THOROUGHFARE DEVELOPMENT PLAN

Commissioner Woehr moved to approve the proposed Thoroughfare Development Plan presented by Ms. Mitchell. Seconded by Commissioner Smith III, the plan was approved by a vote of 8-0-0.

V. PLAT CONSENT AGENDA AND PUBLIC HEARING FOR PLATS

A. Preliminary Plat – Arlington Tech Center Addition, Lots 1-44, and 21X, Block 10 (Zoned "PD-RM12"); generally located north of Gambrel Road and east of South Collins Street with the approximate address being 1200 East Arbrook Boulevard.

Present in support of this case was Josh Steiger, 600 Six Flags Drive, Arlington, TX 76011.

Commissioner Croxton moved to Approve Preliminary Plat – Arlington Tech Center Addition. Seconded by Commissioner Moise, the motion was approved by a vote of 8-0-0.

B. Combination Plat – Holm Addition – Lot 1, Block 1, Zoned Residential Single-Family 15 (RS-15); generally located west of Hamlet Avenue and south of Becky Drive with the approximate address being 7500 Hamlet Avenue.

Commissioner Croxton moved to Approve Combination Plat – Holm Addition. Seconded by Commissioner Moise, the motion was approved by a vote of 8-0-0.

C. Combination Plat – Pendergraft Addition – Lots 1 and 2, Block A, Zoned Residential Single-Family 15 (RS-15); generally located west of Truver Lane and north of West Harris Road with the approximate addresses being 7010 and 7012 Truver Lane.

Commissioner Croxton moved to Approve Combination Plat – Pendergraft Addition. Seconded by Commissioner Moise, the motion was approved by a vote of 8-0-0.

D. Replat – Pioneer Village Addition, Lot 1R, and 4R, Block 1 (Zoned "CC"); generally located south of East Pioneer Parkway and west of Carter Drive with the approximate addresses being 2240 East Pioneer Parkway and 2230 Carter Drive

Commissioner Croxton moved to Approve Replat – Pioneer Village Addition. Seconded by Commissioner Moise, the motion was approved by a vote of 8-0-0.
