- III. Commissioner Ron Smith moved to Approve the minutes of the November 9, 2016, P&Z Regular Session Meeting. Seconded by Commissioner Smith III, the minutes were approved by a vote of 7-0-0.

IV. PLAT CONSENT AGENDA AND PUBLIC HEARING FOR PLATS

A. Replat – Original Town of Arlington – Block 4-AR zoned Downtown Business (DB); generally located north of West Abram Street and east of South Center Street with the approximate address being 101 South Center Street.
