## FY 2021 ANNUAL REPORT AND PROJECT EVALUATION

## **CITY OF ARLINGTON**

On August 23, 2021, The City of Arlington's Floodplain Program for Public Information Committee (FPPIC) met to evaluate the implementation of outreach projects from the Floodplain Program for Public Information (PPI) plan. The FPPIC members attending the meeting were Randy Hendricks, Dale Sharpe-Jenkins, Phyllis Hunter, Melissa Walker, Zachary Holmer, Susan Schrock.

During the development of the Floodplain PPI plan, the FPPIC identified priority audiences for targeted education projects. These target audiences are as follows:

- The City at large
- Repetitive Flood Loss Areas
- Low water crossing and barricade location area residents and business owners
- Students, faculty and staff at UTA, TCC and AISD Campuses
- AISD bus drivers and City of Arlington Handitran drivers and Via drivers
- Hospitals, nursing homes, gas well operators and industrial businesses
- Prospective buyers, lenders, real estate agents, mortgage agencies

- All property owners in the floodplain
- City employees and volunteers
- Entertainment District visitors, shortterm rental property owners, businesses, Chamber of Commerce organizations
- City of Arlington Parks and Recreation Facility visitors and park patrons
- Non-SFHA flood-prone area residents and business owners
- Non-English-speaking residents

The Floodplain PPI Plan identified outreach projects to address the core CRS outreach topics of *Know Your Flood Risk, Promoting Flood Insurance, Protecting People and Property from Flood Hazards, Building Responsibly and Protecting Natural Floodplain Functions.* The Floodplain PPI Committee included four new outreach topics of *Storm Drain Infrastructure, Arlington Watersheds, Guidelines for What to do After a Flood and Diverse Population.*

The Floodplain PPI Plan outlines that these projects will be developed and implemented over a 5-year period. Stormwater staff works with the FPPIC to prioritize projects for development each year. The plan provides a road map for Stormwater Staff to implement these projects. Stormwater Staff implemented the following projects in FY 2021.

- FRP Flood Damage Flyer This flyer was added to our Flood Response Preparation packet which is distributed to residents after a flood event has occurred. The flyer provides guidance on what to do if your property floods.
- Repetitive Loss Annual mailout- Stormwater Staff uses the RLAA map to develop the annual mailout to repetitive loss properties within the City. The mailout includes a letter and a copy of the Citizens Guide to Flood Safety and Preparedness brochure. The letter and brochure are reviewed annually.
- Mayor Flood Insurance postcard mailout Stormwater staff developed a map of flood prone areas within in the city that are not located in the Special Flood Hazard Area. Postcard promoting the benefits of purchasing flood insurance are sent to property owners and tenets each year. 1,330 postcards were mailed out on September 7,2021. This project will be done annually.
- Low Water Crossing/Barricade Location Flood Safety postcard mailout Stormwater staff developed a map of areas adjacent to low water crossings within the City and Public Works and Transportation Department's Barricade locations. A portion of these locations are then sent a Flood Safety postcard. This postcard informs property owners and tenets about the dangers of low water crossings and the purpose for the barricade locations. 902 postcards were mailed out on April 7, 2021. This project will be done annually
- Flood Insurance apartment poster Stormwater staff completed the design for a poster stressing the importance of getting flood insurance for residents of apartment complexes in August of 2021. Staff will begin distribution of posters in the fall of 2021.





During the FPPIC meeting in August, members discussed their priorities for FY2022. The members would like Stormwater staff to focus on development of PSAs; multi-language outreach; flood insurance presentation and training opportunities for insurance agents, mortgage companies and other lenders; flood safety presentation and training opportunities for AISD bus drivers, COA Handi-tran drivers and VIA drivers. The Committee will also be engaging with the public for new committee members in the fall of 2021 since several members have moved out of the area. This will give the committee another opportunity to review the floodplain PPI plan and bring new ideas to its ongoing efforts to raise awareness of flood safety and preparedness projects in the City of Arlington.
