Chair McDaniel called the meeting to order at 6:00 p.m. and stated the purpose of the meeting was to conduct the following items of business:

## **Presentation**

Mr. Lemuel Randolph, Deputy City Manager presented information requested at the previous meeting including an updated Bond Project Map, which reflects a new location for the proposed Fire Station #18 to 2015 W. Mayfield Road.

Ms. Nora Coronado, Director of Asset Management presented a history and overview of the department. Ms. Coronado then presented two proposed vertical projects including a Major Building Components package and a rebuild of the South Public Works Field Operations building & site improvements, totaling \$24,709,191.

Fire Chief Don Crowson then presented the final project of the proposed bond project list, which is a new Fire Station #18 at a cost of \$14,038,993.

### **Discussion**

The Committee Members were given an opportunity to discuss the presentation and have their questions answered by Ms. Coronado and Chief Crowson.

#### **Announcements**

Ms. Lyndsay Mitchell then provided the Committee with a preview of the prioritization process the Committee will begin at the next regular meeting on September 15.

Mr. Randolph announced that Committee will meet for a mobile bus tour, leaving from the west side of City Hall at 1:00 pm on September 9. Mr. Randolph also announced that the first public meeting will be held Monday, September 12 at 6:30 pm at the ReBrary Room of the Downtown Library (100 S. Center Street). In addition, there is an online opportunity to provide feedback on the proposed project list by completing a survey, available on the Committee website, <a href="https://www.arlingtontx.gov/cbc">www.arlingtontx.gov/cbc</a>.

Finally, Mr. Randolph announced that the next meeting will be the first prioritization exercise for the committee to reduce the project list to the available capacity of \$213 million.
