LAND USE TABLES

The tables in Section 3.1 of the Unified Development Code contain the list of land uses that are allowed in each of the zoning districts. The tables indicate whether those uses are permitted by right, require a specific use permit, or have special conditions. There are also tables for accessory uses (Section 3.3) and temporary uses (Section 3.4).

All tables follow the format and content described below.

- 1. **Permitted By-Right Uses.** A "P" in the table indicates the use is permitted by right.
- 2. **Specific Use Permit.** An "S" in the table means the use is only allowed if issued a specific use permit (see Section 10.4.6 of the UDC).
- 3. **Prohibited Uses.** If the cell is blank, that use is prohibited.
- 4. **Supplemental Use Standards.** If an asterisk [*] is in the cell, that use has other special standards that apply. These standards are fully described in the section following each table.
- 5. **Overlay districts.** An overlay district may include other uses that are allowed or prohibited. See the individual overlay for any conditions.
